**AGREEMENT NO. 23-DES-ITB-457
AMENDMENT NUMBER 1**

This Amendment Number 1 is made on the date of execution by the County and amends Agreement Number 23-DES-ITB-457 ("Main Agreement") dated 2/6/2023 between Traffic Systems, LLC ("Contractor") and the County Board of Arlington County, Virginia ("County").

The County and the Contractor agree to amend the Main Agreement as follows:

- I. DELETE PARAGRAPH 4. CONTRACT TERM IN ITS ENTIRETY AND REPLACE IT WITH THE FOLLOWING LANGUAGE:

4. **CONTRACT TERM**

Time is of the essence. The Work will commence on the date of execution by the County and must be completed no later than January 31, 2024 ("Initial Contract Term"), subject to any modifications provided in the Contract Documents. Upon satisfactory performance by the Contractor the County may, through issuance of a bilateral Notice of Renewal, authorize continuation of the Agreement under the same contract prices for not more than four additional 12-month periods, from February 1, 2024, to January 31, 2028 (each a "Subsequent Contract Term"). The Initial Contract Term and any Subsequent Contract Term(s) are together the "Contract Term".

- II. REPLACE EXHIBIT A – PRICE SCHEDULE WITH THE ATTACHED UPDATED EXHIBIT A

All other terms and conditions of the Main Agreement remain in effect.
