**AMENDMENT NUMBER 6**

This Amendment Number 6 ("Amendment") is made on the date of execution of the Amendment by the County and amends Agreement Number 16-150-2-ITB LW, dated March 16, 2016 ("Main Agreement") made between J&M of Northern Virginia, Inc., 7371 Atlas Walkway #642, Gainesville, VA 20155 ("Contractor") and the County Board of Arlington County, Virginia ("County").

Whereas the County and the Contractor desire to amend the Scope of Work, time period(s) of performance and payments called for under the Main Agreement, the Contractor and the County, in consideration of the promises and other good and valuable consideration specified in this amendment, amend the Main Agreement as follows:

I. SW & SE Mowing Reduction of services

II. SCOPE OF SERVICES, GENERAL SPECIFICATIONS, 1. MOWING SEASON

Two weeks reduced in the month of November. Services will also be reduced in the month of April by two weeks and will begin on April 15<sup>th</sup>.
