This Amendment Number 3 is made on the date of execution by the County and amends Agreement Number 17-003-ITB-LW ("Main Agreement") dated September 22, 2016 between Maryland Fire Equipment Corporation, 12284 Wilkins Avenue, Rockville, Maryland 20852 ("Contractor") and the County Board of Arlington County, Virginia ("County").

The County and the Contractor agree to amend the main contract called for under the Main Agreement as follows:

- <u>LIVING WAGE</u>: Effective July 1, 2021 the Living Wage rate will increase from \$15.00 per hour to \$\$17.00 per Hour for Arlington County Agreements (Attachments A and B).
