

RESOLUTION NO. 17-125

A RESOLUTION ACCEPTING THE BID OF ENVIRO TECH CHEMICAL SERVICES, INC., FOR AS NEEDED SUPPLY OF PERACETIC ACID AT A RATE OF \$ 4.01 PER POUND FOR A ONE-YEAR TERM WITH FOUR ONE-YEAR RENEWAL OPTIONS; AUTHORIZING EXPENDITURE OF AN AMOUNT NOT TO EXCEED \$160,400 FOR FISCAL YEAR 2016-2017; AUTHORIZING THE CITY MANAGER TO EXERCISE CONTRACT RENEWAL OPTIONS AND MAKE PURCHASES AS NEEDED DURING THE RENEWAL PERIODS SUBJECT TO BUDGETING AND APPROPRIATIONS; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, bids for as needed supply of Peracetic Acid, required for use with the City's UV Disinfection System, were duly called for and advertised; and

WHEREAS, all bids received were opened on January 18, 2017, and are listed on the Bid Tabulation Sheet attached hereto and made a part hereof; and

WHEREAS, the Business Enterprise Management Director recommends that the bids submitted by Nalco Company and Florida Chemical Supply, Inc., be rejected as non-responsive because their bids did not conform to bid specifications; and

WHEREAS, the Business Enterprise Management Director recommends acceptance of the bid submitted by Enviro Tech Chemical Services, Inc., as the lowest responsible and responsive bid, that the City Manager be authorized to exercise contract renewal options, and that the City Manager be authorized to make purchases of Peracetic Acid as needed during the renewal periods subject to budgeting and appropriations; and

WHEREAS, the Chief Financial Officer has submitted a Sufficiency of Funds Certificate.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF DAYTONA BEACH, FLORIDA:

SECTION 1. The City Commission finds that the lowest and best bid submitted by a responsible and responsive bidder is the following:

SECTION 2. The City Commission finds that the bids submitted by Nalco Company and Florida Chemical Supply, Inc., respectively, are non-responsive.


SECTION 3. The bid of Enviro Tech Chemical Services, Inc., is hereby accepted subject to the terms and conditions of the bid documents.

SECTION 4. The Mayor and City Clerk are hereby authorized to execute an appropriate contract or such documents as may be required in accordance with the bid documents.

SECTION 5. The expenditure of an amount not to exceed \$160,400 for the purchase of the above-referenced chemical from Enviro Tech Chemical Services, Inc., for fiscal year 2016-2017, is hereby approved.

SECTION 6. The City Manager is hereby authorized to exercise contract renewal options with Enviro Tech Chemical Services, Inc., and to make as needed purchases of Peracetic Acid during the renewal periods subject to budgeting and appropriations.
