ARLINGTON COUNTY, VIRGINIA AGREEMENT NO. 21-DHS-EP-203 AMENDMENT NUMBER 1

This Amendment Number 1 ("Amendment") is made on August 14, 2020 and amends Agreement Number 21-DHS-EP-203 dated July 1, 2020 ("Main Agreement") and made between Legal Services of Northern Virginia ("Contractor") and the County Board of Arlington County, Virginia ("County").

The County and the Contractor amend the Main Agreement as follows:

REVISE THE CONTRACT AMOUNT PARAGRAPH 5 TO READ AS FOLLOWS:

The County will pay the Contractor in accordance with the terms of the Payment section below and in the amount of \$430,455.00 for the Contractor's completion of the Work as required by the Contract Documents. Of the \$430,455.00, \$22,000 is offset by a federal grant. In case the County will not be awarded the annual grant amount of \$22,000, the County may change the Scope of Work to reflect the funding change. The Contractor will complete the Work for the total amount specified in this section ("Contract Amount").

The County will not compensate the Contractor for any goods or services beyond those included in the Contract Amount unless those additional goods or services are covered by a fully executed amendment to this Contract.

REVISE THE PAYMENT PARAGRAPH 6 TO READ AS FOLLOWS:

The Contractor must submit twelve monthly invoices in the amount of \$35,871.25 to the County's Project Officer, who will either approve the invoice or require corrections. Each invoice must certify that the invoice submitted is a true and accurate accounting of the work performed and goods and/or services provided and must be signed and attested to by the Contractor or authorized designee. The County will pay the Contractor within forty-five (45) days after receipt of an invoice for completed work that is reasonable and allocable to the Contract and that has been performed to the satisfaction of the Project Officer. The number of the County Purchase Order pursuant to which goods or services have been delivered or performed must appear on all invoices.

All other terms and conditions of the Main Agreement, as amended shall remain in full force and effect.
