AMENDMENT NUMBER 5

This AMENDMENT NUMBER 5 is made on the date of execution by the County and amends Agreement Number 620-14LW dated April 24, 2014, ("Main Agreement") between LT Services, Inc. ("Contractor") and the County Board of Arlington County, Virginia ("County").

The County and the Contractor amend the contract term called for under the Main Agreement as follows:

Remove paragraph 3. Contract Term and replace it with the following:

3. Contract Term

The Contractor's provision of goods and/or services for the County ("Work") shall commence on the date of execution and shall be completed no later than **September 30, 2019** ("Contract Term"), subject to any modifications as provided for in the Contract Documents.
