AMENDMENT NUMBER 1**

This Amendment Number **1** is made on 7/11/2022 by the County and amends Agreement Number **20-223-ITB-3** ("Main Agreement") dated June 2, 2020, between Eurovia Atlantic Coast LLC dba Virginia Paving Company ("Contractor") and the County Board of Arlington County, Virginia ("County").

The County and the Contractor agree to amend the main contract called for under the Main Agreement as follows:


- 1. SM 9.5 RAP** is hereby changed to add **SM-12.5 RAP** as a substitute when applicable, effective immediately.
- 2. CONTRACT TERM:** Pursuant to Section 4. The contract is hereby renewed for its second subsequent contract term beginning July 1, 2022, to June 30, 2023, with two (2) additional 12-month periods remaining.
- 2. BID FORM:** Is hereby deleted in its entirety and replaced with the attached **Revised Bid Form**.


All other terms and conditions of the Main Agreement remain in effect.
