**INTERAGENCY AGREEMENT FOR
FIRE PROTECTION SERVICES**

This AGREEMENT is entered into effective September 1, 2012, by and between **OKALOOSA COUNTY, FLORIDA**, a political subdivision of the State of Florida (hereinafter referred to as the "County"), whose address is 1804 Lewis Turner Boulevard, Suite 100, Fort Walton Beach, Florida 32547 and the **OCEAN CITY-WRIGHT FIRE CONTROL DISTRICT** (hereinafter referred to as the "Fire District"), whose address is 2 Racetrack Road, Fort Walton Beach, Florida 32547.

WHEREAS, the Fire District provides fire and first responder Emergency Medical Services to all unincorporated areas surrounding Fort Walton Beach, including Ocean City, Wright, Shalimar, Poquito Bayou, Cinco Bayou and Sylvania Heights; and

WHEREAS, the Arbennie Pritchett Water Reclamation Facility is a county-owned facility located on property leased by Eglin Air Force Base and is consequently outside the boundaries of the Fire District service area; and

WHEREAS, the Fire District has agreed to provide fire and first responder Emergency Medical Services to the Arbennie Pritchett Water Reclamation Facility under the terms outlined below.

NOW, THEREFORE, for good and valuable consideration, the sufficiency of which is acknowledged by all parties, the County and the Fire District agree as follows:

1. During the term of this Agreement, the Fire District agrees to provide full service fire and first responder Emergency Medical Services protection to the Arbennie Pritchett Water Reclamation Facility, located at 250 Roberts Boulevard, Fort Walton Beach, Florida, which is owned and operated by the County. Such service will be comparable to the services provided within the boundaries of the Fire District. The Fire District may utilize the County's water, water lines and hydrants in providing fire protection to the Arbennie Pritchett Water Reclamation Facility.

2. The Fire District will be responsible for enforcing the fire protection codes, upon receiving notification of a violation. Authorized inspectors of the Fire District shall be permitted to make inspections of the Arbennie Pritchett Water Reclamation Facility, at mutually agreeable dates and times, as deemed necessary to ensure compliance with applicable fire protection codes.
3. Services provided under this Agreement are for a public agency and, therefore, there will be no annual service fees payable by the County to the Fire District under this Agreement.
4. The term of this Agreement shall be for one (1) year commencing with an effective date of September 1, 2012, and ending August 31, 2013. This Agreement shall automatically renew for additional periods of one (1) year unless either party gives at least ninety (90) days written notice to the other party of its intent to terminate the Agreement prior to the expiration of the then current term.
