

## ARLINGTON COUNTY, VIRGINIA AGREEMENT NO. 559-13

## AMENDMENT NUMBER 3

This Amendment Number 3 ("Amendment") is made on the date of execution by the County and amends Arlington County Agreement Number 559-13, dated June 15, 2015 ("Main Agreement as Amended"), and made between JK Moving & Storage, Inc., 44112 Mercure Circle, Sterling, VA 20166 ("Contractor"), a Virginia corporation authorized to transact business in the Commonwealth of Virginia, and the County Board of Arlington County, Virginia ("County").

Whereas the County and the Contractor desire to amend the Contract Term and Notices under the Main Agreement, the Contractor and the County, in consideration of the promises and other good and valuable consideration specified in this Amendment, amend the Main Agreement as follows (revisions are underlined):

Revise Section 3 ("Contract Term") of the Main Agreement, Page 1 as follows:

## 3. CONTRACT TERM

The term of this Agreement will commence on July 1, 2015, and shall be completed no later than <u>June 30</u>, 2025, subject to any modifications as provided for in the Contract Documents.

II. Replace Exhibit B "Pricing Schedule" with attached 2018 Pricing

All other terms and conditions of the Main Agreement, as amended, shall remain in full force and effect.
