

AMENDMENT NUMBER 10

This Amendment Number 10 ("Amendment") is made on the date of execution of the Amendment by the County and amends Agreement Number 430-10, dated June 28, 2011 ("Main Agreement"), amended by Amendment 1 through 9, and made between The Animal Welfare League of Arlington (AWLA), 2650 South Arlington Mill Drive, Arlington, VA 22206 ("Contractor") and the County Board of Arlington County, Virginia ("County").

Whereas the County and the Contractor desire to amend the Contract Team under the Agreement, the Contractor and the County, in consideration of the promises and other good and valuable consideration specified in this Amendment, amend the Agreement as follows


REVISE THE CONTRACT TERM PARAGRAPH TO READ AS FOLLOWS:

The Work shall continue from July 1, 2018, and be completed no later than June 30, 2019 ("Eighth Subsequent Contract Term"), subject to any modifications as provided for in the Contract Documents. Upon satisfactory performance by the Contractor and with the concurrence of the Contractor, the County may authorize continued operations of the Contractor for not more than two (2) additional twelve (12) month periods from July 1, 2019 to June 30, 2021 (Each such period shall be referred to as a "Subsequent Contract Term"). The contract Amount for each Subsequent Contract Term shall be in an amount mutually agreed upon but which will in no event exceed the funds appropriated for the service by the County Board of Arlington County. The total Contract Amount may be increased or decreased during the Subsequent Contract Terms if available funds exceed or, in the alternative, are not sufficient to maintain then current service levels.


All other terms and conditions of the Agreement are unchanged and shall remain in full force and effect.
