STATEMENT OF ISSUE: Staff request approval of the 2nd Amendment requesting an increase to the Fiscal Year Budget from \$60,000 to \$90,000 and the renewal of the Contract with Gulf Coast Kids House, Inc. (C20-2878-BCC) retroactive to October 1. 2023 and the authorization to pay the outstanding Gulf Coast Kids House, Inc. invoices in the amount of \$34,200.

BACKGROUND: Pursuant to §39.303, Florida Statutes, the Children's Medical Services Program of the Department of Health is tasked with designating Child Protection Teams in each service district of the Department of Children and Families to conduct medical examinations of allegedly abused, abandoned, or neglected children.

Also pursuant to §39.304(5), Florida Statutes, the County in which a child is a resident shall bear the initial costs of medical examinations of allegedly abused, abandoned, or neglected children that are conducted by the designated Child Protection Team.

There is no limit to the number of examinations performed and the increase in the budgeted amount unfortunately reflects the trend against one of society's most vulnerable.

The Board of County Commission entered into a Contract with Gulf Coast Kids House, Inc. on October 1, 2019, to formalize this statutory requirement.
