

ARLINGTON COUNTY, VIRGINIA AGREEMENT NO. 22-DHS-EP-573 AMENDMENT NUMBER 1

This Amendment Number 1 is made on the date of execution by the County and amends Agreement Number 22-DHS-EP-573 ("Main Agreement") dated January 7, 2022, between Tribute at One Loudoun, LLC ("Contractor") and the County Board of Arlington County, Virginia ("County").

The County and the Contractor agree to amend the Main Agreement as follows:

1. REPLACE SECTION 4. CONTRACT TERM WITH THE FOLLOWING LANGUAGE:

4. CONTRACT TERM

Time is of the essence. The Work will commence on date of execution and must be completed no later than December 31, 2022. ("Initial Contract Term"), subject to any modifications provided in the Contract Documents. Upon satisfactory performance by the Contractor the County may, through issuance of a bilateral Notice of Renewal, authorize continuation of the Agreement under the same contract prices for not more than four (4) additional 12-month periods, from January 1, 2023 to December 31, 2026 (each a "Subsequent Contract Term"). The Initial Contract Term and any Subsequent Contract Term(s) are together the "Contract Term".

- 2. PURSUANT TO SECTION 4. CONTRACT TERM, THIS CONTRACT IS HEREBY RENEWED FROM JANUARY 1, 2024 TO DECEMBER 31, 2024.
- 3. PURSUANT TO SECTION 5. CONTRACT PRICING, THE COUNTY WILL PAY THE CONTRACTOR IN ACCORDANCE WITH EXHIBIT E ATTACHED.
- 4. REMOVE SECTION 11. COVID-19 VACCINATION POLICY FOR CONTRACTORS IN ITS ENTIRETY.
- 5. REPLACE SECTION 48. NOTICES WITH THE FOLLOWING:
