## AGREEMENT FOR THE HOUSING OF INMATES

THIS agreement made and entered into this day of day of day of Soleman 2000, by and between the Boards of County Commissioners of Okaloosa County, Florida and Escambia County, Florida, is done in accordance with section 951.13, Florida Statutes, as amended.

WHEREAS Escambia County Road Prison officials have agreed to house inmates for and in behalf of the Okaloosa County Department of Corrections in accordance with section 951.13, Florida Statutes, as amended.

The Okaloosa County Department of Corrections shall provide the Escambia County Road Prison officials with sentenced county prisoners in accordance with criteria established in section 950.002(9), Florida Statutes, as amended.

Escambia County Road Prison officials agree to bear the cost of guarding and maintaining such prisoners, and to provide for the safekeeping, proper care, and safe return of such prisoners except that prisoners that develop serious medical problems may be returned to Okaloosa County as soon as they are medically able to be returned as determined by a physician.

Escambia County Road Prison officials agree to provide transportation for such inmates to and from the Okaloosa County Jail.

Escambia County Road Prison officials agree to provide privileges and services to such inmates in accordance with Florida Model Jail Standards.

Escambia County Road Prison officials and the Okaloosa County Department of Corrections agree that such prisoners shall be put to work inside the Escambia County Road Prison compound.

This Agreement may be suspended or terminated after 30 days notice by either county.

This Agreement, after being properly executed by all parties named herein, shall become effective upon filing with the Clerks of the Circuit Courts of Escambia and Okaloosa Counties. Each County shall be responsible for filing this document upon receipt of the executed Agreement.
