This Amendment Number 3 is made on the date of execution by the County and amends Agreement Number 621-12-LW dated March 8, 2012, ("Main Agreement") between SecurCorp, Inc ("Contractor") and the County Board of Arlington County, Virginia ("County").

The County and the Contractor amend number 3. Contract Term called for under the Main Agreement as follows:

# **Contract Term**

The contract term is hereby renewed for the period beginning **January 1**, **2020** and ending **December 31**, **2020**.

This is the FOURTH of a possible FIVE, 12-month renewal of the "subsequent contract term."

# Contract Pricing

The 2020 Hourly Rate is increased 2.5% to \$22.41.

- Overtime Hourly Rate is 1.5 times the Hourly Rate. The Contractor can only
  charge overtime to the County if the County fails to notify the change in hours
  within 14 hours to the security firm and causes the guard to work over 40 hours
  in any one week.
- Holiday Hourly Rate is 2.0 times the Hourly Rate. Holidays include: New Year's Day, Memorial Day, Independence Day, Labor Day, Thanksgiving, Day after Thanksgiving and Christmas Day.

All other terms and conditions of the Main Agreement remain in effect.
