## AGREEMENT NO. 20-807 AMENDMENT NUMBER 1

This **Amendment Number 1** is made on **October 15, 2021** by the County and amends Agreement Number 20-807 ("Main Agreement") dated November 27, 2019 between **Traffic Systems, LLC.** ("Contractor") and the **County Board of Arlington County, Virginia** ("County").

The County and the Contractor agree to amend the Main Agreement as follows:

- 1. PURSUANT TO PRVISION 4: **CONTRACT TERM**, THE COUNTY HEREBY EXERCISES THE 2<sup>ND</sup> OF FOUR (4) ONE YEAR OPTION EXTENSIONS FOR THE PERIOD OF NOVEMBER 27, 2021 TO NOVEMBER 26, 2022.
- 2. DURING THIS RENEWAL PERIOD, EXHIBIT A: PRICE SCHEDULE IS REPLACED IN ITS ENTIRETY WITH THE ATTACHED EXHIBIT A: PRICE SCHEDULE, which is incorporated into and made a part of this Amendment No. 1.
- 3. PROVISION 50: NOTICES, remove Shirley Diamond, Procurement Officer and replace with:

4. ADD PROVISION 54: **SEXUAL HARRASSMENT POLICY**, which is incorporated into and made part of this Amendment as follows:

#### **54. \*SEXUAL HARASSMENT POLICY**

If the Contractor employs more than five employees, the Contractor shall (i) provide annual training on the Contractor's sexual harassment policy to all supervisors and employees providing services in the Commonwealth, except such supervisors or employees that are required to complete sexual harassment training provided by the Department of Human Resource Management, and (ii) post the Contractor's sexual harassment policy in (a) a conspicuous public place in each building located in the Commonwealth that the Contractor owns or leases for business purposes and (b) the Contractor's employee handbook.

5. ADD PROVISION 55: **COVID-19 VACCINATION POLICY FOR CONTRACTORS**, which is incorporated into and made part of this Amendment as follows:

Due to the ongoing COVID-19 pandemic, the County has taken various steps to protect the welfare, health, safety, and comfort of the workforce and public at large. As part of these steps, the County has implemented various requirements with respect to health and safety including policies with respect to social distancing, the use of face-coverings and vaccine mandates. To protect the County's workforce and the public at large, all employees and subcontractors of the Contractor who are assigned to this Contract, must be fully vaccinated against COVID-19. Any contractor employee or subcontractor who is not fully vaccinated should be following a weekly

testing protocol as established by the Contractor unless exempt pursuant to a valid reasonable accommodation under state or federal law.

All other terms and conditions of the Main Agreement remain in effect.
