## **RESOLUTION NO. 13-159**

APPROVING RENEWAL AND A RESOLUTION AMENDMENT OF THE CONTRACT WITH USA SERVICES OF FLORIDA, INC., TO PROVIDE CITYWIDE STREET SWEEPING SERVICES FOR AN ADDITIONAL FIVE-YEAR PERIOD AT A COST NOT TO EXCEED \$354,830 IN THE **APPROPRIATIONS FIRST** YEAR, **SUBJECT** TO THEREAFTER; WAIVING THE PROHIBITION AGAINST RENEWAL OF A CONTRACT FOR A PERIOD EXCEEDING THE TIME PERIOD IN THE INVITATION TO BID; AUTHORIZING THE MAYOR AND CITY CLERK TO EXECUTE AMENDMENT NO. 1 TO THE CONTRACT WITH USA SERVICES OF FLORIDA, INC., PROVIDING FOR RENEWAL AND AMENDMENT; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, by Resolution No. 10-236, the City Commission entered into a contract with USA Services of Florida, Inc., (USA) for citywide street sweeping services for a three-year period commencing October 1, 2010, with one three-year option to renew, at a cost not to exceed \$354,830 in the first year and subject to amounts budgeted and appropriated in subsequent years; and

WHEREAS, USA's performance throughout the first three-year term of the contract has been exceptional and the City would like to renew the contract; and

WHEREAS, USA desires to extend the contract for a five-year period (instead of three) and has agreed to waive the CPI adjustments during the additional five year term and to increase the frequency of residential sweeping during the October and November leaf season from once a month to twice a month at no additional charge; and

WHEREAS, renewal of a contract beyond the time period specified in the Invitation to Bid is prohibited by § 30-144(b), City Code, unless requirements are waived by the City Commission pursuant to § 30-58, City Code; and

WHEREAS, the Invitation to Bid in this instance specified an initial three-year term with one three-year renewal term; and

WHEREAS, the Deputy City Manager/Operations recommends waiver of § 30-144(b), City Code, and approval of Amendment No. 1 to the Contract with USA Services of Florida, Inc., providing for renewal for a five-year term and incorporating the conditions described above; and

WHEREAS, the Chief Financial Officer has filed a Sufficiency of Funds Certificate.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF DAYTONA BEACH, FLORIDA:

SECTION 1. The City Commission hereby finds that it is in the best interests of the City to extend the contract with USA Services of Florida, Inc., for an additional five-year period, and waives the requirement of § 30-144(b), City Code.

SECTION 2. Renewal of the Contract with USA Services of Florida, Inc., for

citywide street sweeping services for a five-year period commencing October 1, 2013, at a cost

not to exceed \$354,830 in the first year and subject to amounts budgeted and appropriated in

subsequent years, and amendment of the contract to delete CPI adjustments and to increase the

frequency of residential sweeping during the months of October and November to twice a month,

are hereby approved.

SECTION 3. The Mayor and the City Clerk are hereby authorized to execute

Amendment No. 1 to Services Contract with USA Services of Florida, Inc., a copy of which in

substantially final form is attached hereto and made a part hereof by reference.
