AGREEMENT NO. 19-071-2-RFP-LW AMENDMENT NUMBER 6

This Amendment Number **6** is made on $\frac{11/2/2022}{2}$ and amends Agreement Number **19-071-2-RFP-LW**, ("Main Agreement") dated **December 4, 2019**, between New Hope Housing, Inc. ("Contractor") and the County Board of Arlington County, Virginia ("County").

The County and the Contractor agree to amend the Main Agreement as follows:

I. <u>PURSUANT TO CLAUSE 4: CONTRACT TERM, THE COUNTY HEREBY RENEWS FOR THE PERIOD OF</u> DECEMBER 4, 2022, to DECEMBER 3, 2023, WITH ONE (1) ONE-YEAR REMAINING.

II. <u>PURSUANT TO CLAUSE 6: CONTRACT PRICE ADJUSTMENTS, INCREASE THE CONTRACT PRICE BY A</u> <u>FOUR PERCENT (4%) CPI-U INCREASE, NOT TO BE CHANGED BETWEEN DECEMBER 4, 2022, AND</u> <u>DECEMBER 3, 2023, AS SET FORTH IN CONTRACT CLAUSE 6.</u>

III. REPLACE REVISED EXHIBIT B, CONTRACT PRICING, IN ITS ENTIRETY WITH THE ATTACHED REVISED EXHIBIT B, CONTRACT PRICING.

Pricing from **December 4, 2022, to December 3, 2023,** shall be in accordance with Revised Exhibit B, Contract Pricing.

In accordance with Revised Exhibit B, the Contract Amount is hereby increased by \$36,528 to reflect a 4% CPI-U adjustment. The Contract Amount is hereby changed from **\$913,199** to **\$949,727**.

All other terms and conditions of the Main Agreement, as amended shall remain in full force and effect.
