AGREEMENT NO. 20-703-EP AMENDMENT NUMBER 30

This Amendment Number 30 is made on the date of execution by the County and amends Agreement Number 20-703-EP ("Main Agreement") dated July 14, 2009 between Arlington Thrive ("Contractor") and the County Board of Arlington County, Virginia ("County").

The County and the Contractor agree to amend the main contract called for under the Main Agreement as follows:

Add the following Language to Paragraph 1. Contract Amount:

1. CONTRACT AMOUNT

The County is providing an additional \$1,600,000 in one-time funding, for the Carter-Jenkinson Housing Assistance Fund as reflected in Attachment A – Revised FY2021 Budget. The County is also providing an additional one-time amount of \$50,000 for the Permanent Supportive Housing Emergency Fund ("PSH-EF").

The County will pay the Contractor in one lump sum upon execution of the amendment. All current eligibility requirements/documentation and contract reporting requirements apply; however, the Contractor must submit a separate report for the Carter-Jenkinson funding (Attachment B).

For services rendered by the Contractor and accepted by the Project Officer, the County shall pay the Contractor a total of up to \$3,998,495.23 for the contract period. The County shall not pay the Contractor any other sum under this Agreement.

All other terms and conditions of the Main Agreement, as amended shall remain in full force and effect.
