This Amendment Number **19-149-2-ITB-2** is made on _____ by the County and amends Agreement Number **2** ("Main Agreement") dated September 5, 2019, between Ferguson Waterworks ("Contractor") and the County Board of Arlington County, Virginia ("County").

The County and the Contractor agree to amend the main contract called for under the Main Agreement as follows:

1. CONTRACT TERM: Pursuant to Section 3. The contract is hereby renewed for the contract term beginning October 1, 2022, to September 30, 2023, with one (1) additional 12-month period remaining.

2. CONTRACT PRICE INCREASE: Pursuant to Section 4. Contract Pricing With Optional Price Adjustments, the contract amount/unit prices is hereby increased per the U.S. Department of Labor, Consumer Price Index, All items, Unadjusted, Urban Areas ("CPI-U"), for the 12-month period ending in September of each year of the Contract.

3. PRICE SHEET is hereby deleted in its entirety and replaced with the attached **Revised Price Sheet**. Pricing from **October 1, 2022, to September 30, 2023**, shall be in accordance with the **Revised Price Sheet**.
