**AGREEMENT NO. 19-835-R  
AMENDMENT NUMBER 1**

This **Amendment Number 1** is made on the date of execution by the County and amends **Agreement Number 19-835-R** ("Main Agreement") dated May 6, 2019, between **Enterprise RAC Company of Maryland, LLC**. ("Contractor") and the County Board of Arlington County, Virginia ("County").

The County and the Contractor agree to amend the Main Agreement as follows:

**1. REPLACE PARAGRAPH 2. CONTRACT TERM WITH THE FOLLOWING:**

**2. CONTRACT TERM**

The Contractor's provision of goods and services for the County ("Work") shall commence upon the execution of the Agreement by the County," and shall be completed no later than April 24, 2020 ("Contract Term"), subject to any modifications as provided for in the Contract Documents regarding the Contract Term. No aspect of the Work shall be deemed complete until it is accepted by the County's Project Officer.

Upon satisfactory performance by the Contractor, if the County of Loudoun, Virginia renews their agreement identified in Contract Documents, the County may elect to renew this Agreement under the same contract terms for five (5) one-year renewal periods from April 25, 2020 to April 24, 2025 ("Subsequent Contract Term"). However, if the County of Loudoun, VA does NOT renew their agreement identified in the Contract Documents, this Agreement shall automatically expire on the contract expiration date.

**2. PURSUANT TO PARAGRAPH 2. CONTRACT TERM, THIS AGREEMENT IS HEREBY RENEWED FROM APRIL 25, 2023 TO APRIL 24, 2024.**
