

This Amendment Number 1 ("Amendment") is made on the date of execution of the Amendment by the County and amends Agreement dated August 4, 2017 ("Main Agreement") and made between PRS, Inc., 1761 Old Meadow Road, Suite 100, McLean, Virginia 22102 ("Contractor") and the County Board of Arlington County, Virginia ("County").

Whereas the County and the Contractor desire to amend the Arlington Scope of Work, Attachment A under the Main Agreement, the Contractor and the County, in consideration of the promises and other good and valuable consideration specified in this Amendment, amend the Main Agreement as follows.

Increase number of Full Time Employees (FTE) total from 5.2 to 6.2

1. REVISE THE GENERAL REQUIREMENTS AS FOLLOWS:

- A. Provide Employment Services Specialists for the Operation of the County's Job Avenue's Program to serve mentally impaired adults and youth 6.2 Employment Specialists FTE Total.


2. REVISE COST AS FOLLOWS:
