**AGREEMENT NO. 20-716-EP
AMENDMENT NUMBER 1**

This Amendment Number 1 is made on the date of execution by the County and amends Agreement Number 20-716-EP ("Main Agreement") dated September 16, 2019 between Amos Kennedy ("Contractor") and the County Board of Arlington County, Virginia ("County").

The County and the Contractor agree to amend the main contract called for under the Main Agreement as follows:

Due to the COVID-19 Pandemic, components of the project were delayed and will be rescheduled by the Project Officer. The following paragraphs are amended:

1. The Contractor agrees to provide the following goods or services:

Revise Bullet Number 1:

- o Design, letterpress print and ship seven different 6"x9" cards (total amount: 7000 cards) that commemorate the 60th Anniversary of the sit-ins in Arlington, County, Virginia to be delivered to Arlington Cultural Affairs, 3700 South Four Mile Run Drive, Arlington VA 22206 by December 15, 2020

Revise:

- 4. The Contractor shall provide the service designated in Paragraph 1 beginning on the date of execution of this Agreement by the County, and unless terminated as provided below, shall continue until **June 30, 2021**
