AMENDMENT NUMBER 3**

This Amendment Number 3 is made on the date of execution by the County and amends Agreement Number 16-236-ITB-LW ("Main Agreement") dated March 16, 2017 between Rojani Facilities Management, LLC ("Contractor") and the County Board of Arlington County, Virginia ("County").

The County and the Contractor agree to amend the main contract called for under the Main Agreement as follows:

1. Pursuant to section II. Scope of Services number 7., the County hereby adds the following building to Group I:

The County shall pay the Contractor per service at \$1,948 two times per year. Annualized cost shall not exceed \$3,896.
