# AGREEMENT NO. 21-DES-ITB-618b AMENDMENT NUMBER 1

This Amendment Number 1 is made on the date of execution by the County and amends Agreement Number 21-DES-ITB-618b ("Main Agreement") dated 5/15/2021 between Espina Paving, Inc. ("Contractor") and the County Board of Arlington County, Virginia ("County").

The County and the Contractor agree to amend the main contract called for under the Main Agreement as follows:

## **COVID-19 VACCINATION POLICY FOR CONTRACTORS**

Any contractor employee or subcontractor who is not fully vaccinated should be following a weekly testing protocol as established by the Contractor, unless exempt pursuant to a valid reasonable accommodation under state or federal law.
