This **Amendment Number 1** ("Amendment") is made on **June 24, 2020** by the County and amends **Agreement Number 19-723-EP** dated **April 22, 2019** ("Main Agreement"), and made between **Royal Haven** ("Contractor") and **The County Board of Arlington County, Virginia** ("County").

Royal Haven and the County entered into the Main Agreement for Royal Haven to provide individual assisted living services.

Woods Cove Assisted Living, Inc. has assumed all Royal Haven's rights and obligations in the Main Agreement. The work and payment called for under this Amendment shall be subject to all terms and conditions of the Main Agreement unless specifically changed by the terms and conditions of an additional amendment.

The County consents to the assignment of the Main Agreement to Woods Cove Assisted Living, Inc. beginning on June 24, 2020 ("Effective Date").

The Main Agreement is therefore amended as follows:

1. Royal Haven is in all instances replaced with Woods Cove Assisted Living, Inc.;
2. The term "Contractor" in the Main Agreement means Woods Cove Assisted Living, Inc.;


