## AMENDMENT NUMBER 1 ASSIGNMENT OF AGREEMENT

This Amendment Number 1 ("Amendment") is made on  $\frac{6/8/2022}{2}$  by the County and amends Agreement Number 22-DHS-EP-23 ("Main Agreement") between Volunteers of America, Inc., 1660 Duke Street, Alexandria, VA 22314 ("Contractor"), and the County Board of Arlington County, Virginia ("County").

Volunteers of America, Inc. and the County entered into the Main Agreement for Volunteers of America, Inc. to provide Developmental Disabilities Residential Services.

- 2. The term "Contractor" in the Main Agreement means Volunteers of America Chesapeake, Inc.;
