AMENDMENT NUMBER 1

This Amendment Number 1 is made on the date of execution by the County and amends Agreement Number 20-670-AG ("Main Agreement") dated November 18, 2019 between District 19 Community Services Board ("Contractor") and the County Board of Arlington County, Virginia ("County").

The County and the Contractor agree to amend the main contract called for under the Main Agreement as follows:

Revise Section 5 "Contract Amount" as follows: This is a fixed-price contract. The Contractor agrees that the total payment for the Work will not exceed \$33,640.48 (Year 1 – this includes a one-time cost of up to \$11,400.48 and ongoing costs of \$22,200.00) and \$22,200.00 (Year 2), regardless of the number of hours spent in the performance of the Work, Exhibit B of the main agreement is replaced with the revised version as attached to this amendment.
