Whereas the County and the Contractor desire to amend Attachment A, in consideration of the promises and other good and valuable consideration specified in this Amendment, amend Attachment A as follows:

# II. THE FOLLOWING DEFINITIONS FROM SECTION 1 ARE REPLACED WITH THE FOLLOWING LANGUAGE:

Bicycle means a bicycle used in the Capital Bikeshare system.

Customer Key means a key fob used to rent Bicycles from Capital Bikeshare Stations.

Day Key Member means a registered member possessing a key fob who is charged per day when using a Bicycle.

Fleet means one hundred percent (100%) of the number of Bicycles purchased through this Contract minus the number of stolen and irreparable Bicycles owned by the County.

Member Jurisdictions means the municipalities that provide, or soon will provide, Capital Bikeshare Service: Washington, D.C.; Cities of Alexandria and Falls Church, Arlington and Fairfax Counties, Virginia; and Montgomery and Prince Georges Counties, Maryland.

Operational Bicycle means a Bicycle in operating condition and either available for customer use while docked at a Station, in use by a member, or in the process of being returned to a Station.

Operations Manager means the Contractor's representative that directly reports to the General Manager. The Operations Manager manages the day-to-day operations regarding maintenance services of the Capital Bikeshare service, such as, but not limited, to Bicycle rebalancing, maintenance, installation, and repair of Bicycles and Stations.

## III. REPLACE SECTION 2.N.1.G IN ITS ENTIRETY WITH THE FOLLOWING LANGUAGE:

Replace Batteries, as needed, subject to County's payment to Contractor for such Batteries at the rates set forth in the applicable line item in the price table, with the labor at the Contractor's cost.
