Please consider this letter as the notice to proceed work at the Jerry D. Mitchem Water Reclamation Facility (Fairchild Rd, Crestview), as outlined in your quote dated June 2, 2022. We expect the work to be performed for the price quoted in that correspondence. Your total estimate is \$10,616.00 for the scope of work described.

We expect you to bring in this work at or below this amount. Please note that any work that may be charged in excess of your estimate will require prior written approval from OCWS. We understand that the inspection of this pump may lead to additional necessary work (i.e. parts & labor or pump replacement), which would be authorized by a separate, future Notice to Proceed.

The County has the right to inspect all work. When the pump is disassembled and under inspection at your shop, please stay in touch with Nick Enders, who may want to inspect it as well, depending what repairs are needed.

Please also allow me to touch on some housekeeping. This work is above and beyond the work from past Notice to Proceeds (NTPs) also related to the Jerry D. Although those NTPs said "Effluent Pump #1", it was actually the 1st effluent pump to be pulled and repaired, but labeled as Effluent Pump #2 in the field. This NTP from 6/7/2022 is the 2nd effluent pump to be pulled, and it is actually Effluent Pump #1 in the field.
