

AMENDMENT NUMBER 1

ASSIGNED CONTRACT NO. 760-14-1LW

This Amendment Number 1 ("Amendment") is made on the date of execution of the Amendment by the County and amends Agreement ("Main Agreement") and made between Temporary Solutions, Inc., 10550 Lidon Lake Plaza, Suite 200 Manassas, Virginia 20109 ("Contractor") and the County Board of Arlington County, Virginia ("County").

Whereas the County and the Contractor desire to amend the Contract Term under the Main Agreement, the Contractor and the County, in consideration of the promises and other good and valuable consideration specified in this Amendment, amend the Main Agreement as follows.

1. REVISE THE CONTRACT TERM PARAGRAPH TO READ AS FOLLOWS:

The Contractor's provision of goods and/or services for the County ("Work") shall commence on the date of execution and shall be completed no later than August 31, 2018 ("Initial Contract Term"), subject to any modifications as provided for in the Contract Documents. Upon satisfactory performance by the Contractor and with the concurrence of the Contractor, the County may authorize continued operations of the Contractor under the same contract unit prices for not more than four (4) additional twelve (12) month periods from September 1, 2018 to August 31, 2022 (each such period shall be referred to as a "Subsequent Contract Term").

All other terms and conditions of the Main Agreement, as amended shall remain in full force and effect.
