¹ Process Subordination Agreements - This fee is for Subordination Processing only. AmeriNat charges a separate fee for Loan Modification analysis, which is shown on the following page.

²Tax and Insurance Monitoring Service Fee: A onetime charge of \$69.00 per loan upfront at time of servicing commencement will be charged (may be assessable to borrower) for all loan amounts up to \$500,000. For loan amounts over \$500,000 there is an additional charge of \$10 per \$100,000. Once this service is purchased for a loan, Monthly Loan Servicing costs for amortized and deferred loans include ongoing tax and insurance monitoring. Future charges may vary based on outside vendor pricing. Please note: Any additional or supplemental charges

that may be imposed by the respective taxing authority for procurement of duplicate tax bills will be directly passed through to the County.

Note that additional services requested of AmeriNat and agreed to in writing that are not specifically set forth in the Scope of Work (Exhibit A) or this Exhibit B shall be performed and compensated at the hourly rate of \$150/hour.

^{*}Outside costs include, but are not limited to, title, credit, and appraisal/valuation. These costs are passed through from outside vendors and are subject to marketplace increases.
