# AGREEMENT NO. 623-12 **AMENDMENT NUMBER 10**

This Amendment Number 10 is made on March 18, 2020 by the County and amends Agreement Number 623-12 ("Main Agreement") dated April 2, 2012 between Professional Pest Solutions, LLC ("Contractor") and the County Board of Arlington County, Virginia ("County").

- · Suspend pest management services at the locations highlighted on the Revised Bid Form. The services will be suspended until April 30, 2020 ("Suspension Date). Within ten (10) days of the suspension date, the County will notify the Contractor if the date needs to be extended further.
- Pricing from March 18, 2020 to April 30, 2020 shall be in accordance with Revised Bid Form. The Grand Monthly total for "A" through "E" List is \$2,728.04.
