The rate is prorated for the days used over 30 until the exchange and retroactively take effect March 8, 2024.
- 2. **OTHER PROVISIONS REMAIN IN EFFECT.** Except as specifically modified herein, all terms and conditions of the original Agreement between the parties, dated September 7, 2022, and any amendments thereto, shall remain in full force and effect.
- 3. **CONFLICTING PROVISIONS.** The terms, statements, requirements, or provisions contained in this Amendment shall prevail and be given superior effect and priority over any conflicting or inconsistent terms, statements, requirements or provisions contained in any other document or attachment.
