

AGREEMENT NO. 507-12  
AMENDMENT NUMBER 5

This Amendment Number 5 ("Amendment") is made on the date of execution of the Amendment by the County and amends Agreement Number 507-12, dated 04/17/2012 ("Main Agreement") as amended by Amendment No 1 through 4, and made between Social Solutions Global, Inc., 425 Williams Court, Suite 100, Baltimore, MD 21220 ("Contractor") and the County Board of Arlington County, Virginia ("County").

Whereas the County and the Contractor desire to amend the Contract Term under the Main Agreement, the Contractor and the County, in consideration of the promises and other good and valuable consideration specified in this Amendment, amend the Main Agreement as follows.

REVISE THE FOLLOWING TO READ AS FOLLOWS:

Exhibit A, Scope of Work: Add the following requirement: The Contractor will provide a Custom Support Package (10 hours/month) for a fixed fee of \$20,400 annually to be billed in monthly increments of \$1,700. The package will be used when the County requests support above what is stipulated in the original contract Tasks 1 through 10, and once the level of effort for any additional support request is agreed upon by both parties.

Exhibit C, Payment Schedule will be revised as follows:

3. CONTRACT TERM

The work shall continue from April 17, 2017 through April 30, 2018 and the Contractor shall maintain and support the system described in Exhibit A for this period.


4. CONTRACT AMOUNT

The County will pay the contractor in accordance with the terms of the Payment paragraph below, and Exhibit C for the Contractor's completion of the work described and required in the contract documents. The Contractor agrees that it shall complete the Work for an amount not to exceed \$211,400.00 annually for all concurrent licenses (\$28,000 for HMIS and \$163,000 for non-HMIS licenses) and \$20,400 annually for the Custom Support Package to be billed in monthly increments of \$17,616.67. No additional compensation will be paid for work within the Scope of Work of this Agreement. The Contractor agrees that it shall complete the work for the total contract amount specified in this section unless such amount is modified as provided in this Agreement.

All other terms and conditions of the Main Agreement, as amended, shall remain in full force and effect.


