

**AGREEMENT NO. 19-090-R
AMENDMENT NUMBER 1**

This Amendment Number 1 is made on the date of execution by the County and amends Agreement Number **19-090-R** ("Main Agreement") dated February 21, 2019 between **National Elevator Inspection Services, Inc.** ("Contractor") and the County Board of Arlington County, Virginia ("County").

The County and the Contractor agree to amend the main contract called for under the Main Agreement as follows:

SECTION 2. CONTRACT TERM SHALL HEREBY READ:

The Contractor's provision of goods for the County ("Work") shall commence on the date of execution of this Agreement by the County and shall be completed no later than November 30, 2019 ("Initial Contract Term"), subject to any modifications as provided for in the Contract Documents.

Due to satisfactory performance by the Contractor and Loudoun County Government renewal of the contract, the agreement is renewed from December 1, 2019 through November 30, 2021 under the same contract terms.

Upon continued satisfactory performance by the Contractor, if Loudoun County Government renews their agreement identified in Exhibit A, the County may elect to renew this Agreement under the same contract terms for three (3) two (2) year renewal periods from December 1, 2021 to November 30, 2027 ("Subsequent Contract Term"). However, if Loudoun County Government does NOT renew their agreement identified in Exhibit A, this Agreement shall automatically expire on the date of the contract expiration date.


All other terms and conditions of the Main Agreement remain in effect.
