AGREEMENT NO. 530-15-RFP AMENDMENT NUMBER 9

This Amendment Number 9 is made on February 2, 2022 and amends Agreement Number 530-15-RFP ("Main Agreement") dated March 29, 2016 between Accela, Inc. ("Contractor") and the County Board of Arlington County, Virginia ("County").

The County and the Contractor agree to amend the Main Agreement as follows:

1. REPLACE CONTRACT CLAUSE 4. CONTRACT TERM IN ITS ENTIRETY AS FOLLOWS:

4. CONTRACT TERM

The Work will commence on March 31, 2016 and must be completed no later than June 30, 2020 ("Initial Contract Term"), subject to any modifications provided in the Contract Documents. Upon Satisfactory performance by the Contractor the County may, through issuance of a unilateral Notice of Renewal, authorize continuation of the Agreement under the agreed upon contract prices for seven (7) additional 12-month periods, from July 1, 2020 to June 30, 2027 (each a "Subsequent Contract Term"). Upon Satisfactory performance by the Contractor the County may, through issuance of a bilateral Notice of Renewal, authorize continuation of the Agreement under the negotiated pricing subject to the limits in Exhibit B for five (5) or more additional 12-month periods (each a "Subsequent Contract Term"). The Initial Contract Term and any Subsequent Contract Term(s) are together the "Contract Term".

- 2. RENEW THE CONTRACT AS AUTHORIZED BY PARAGRAPH 4. CONTRACT TERM FOR THE SECOND SUBSEQUENT CONTRACT TERM FROM JULY 1, 2021 TO JUNE 30, 2022.
- 3. ADD CONTRACT CLAUSE 52. COVID-19 VACCINATION POLICY FOR CONTRACTORS AS FOLLOWS:

52. COVID-19 VACCINATION POLICY FOR CONTRACTORS

Due to the ongoing COVID-19 pandemic, the County has taken various steps to protect the welfare, health, safety, and comfort of the workforce and public at large. As part of these steps, the County has implemented various requirements with respect to health and safety including policies with respect to social distancing, the use of face-coverings and vaccine mandates. To protect the County's workforce and the public at large, all employees and subcontractors of the Contractor who are assigned to this Contract, should be fully vaccinated against COVID-19. Any contractor employee or subcontractor who is not fully vaccinated should be following a weekly testing protocol as established by the Contractor, unless exempt pursuant to a valid reasonable accommodation under state or federal law.

4. All other terms and conditions of the Main Agreement remain in effect.
