

RESOLUTION NO. 15-246

A RESOLUTION ACCEPTING THE BID OF VETERAN 1 LAWN CARE 'LLC.', FOR AS-NEEDED LOT CLEARANCE AND NUISANCE ABATEMENT SERVICES FOR A PERIOD OF ONE YEAR WITH TWO ONE-YEAR RENEWAL OPTIONS; AUTHORIZING THE MAYOR AND CITY CLERK TO EXECUTE A CONTRACT IN ACCORDANCE WITH THE BID DOCUMENTS; AUTHORIZING EXPENDITURE FOR FISCAL YEAR 2015-2016 IN A TOTAL AMOUNT NOT TO EXCEED \$100,000; AUTHORIZING THE CITY MANAGER TO EXERCISE THE OPTIONS TO RENEW AND MAKE SUCH EXPENDITURES DURING RENEWAL TERMS AS ARE BUDGETED AND APPROPRIATED; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, bids for As-Needed Lot Clearance and Nuisance Abatement services were duly called for and advertised; and

WHEREAS, all bids received were opened on August 6, 2015, and are listed on the Bid Tabulation attached hereto and made a part hereof; and

WHEREAS, the Public Works Director recommends that the bid submitted by Ultimate Kutz Service, Inc., be rejected as non-responsive because the bid did not fully meet specifications; and

WHEREAS, the Public Works Director recommends acceptance of the bid submitted by Veteran 1 Lawn Care 'LLC.', as the lowest responsible and responsive bid and execution of contract documents; and

WHEREAS, the City Manager recommends acceptance of the bid submitted by Veteran 1 Lawn Care 'LLC.'; and

WHEREAS, the Chief Financial Officer has submitted a Sufficiency of Funds Certificate in the amount of \$100,000 for services under the contract during fiscal year 2015-2016.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF DAYTONA BEACH, FLORIDA:

SECTION 1. The City Commission finds that the lowest and best bid submitted by a responsive and responsible bidder is from Veteran 1 Lawn Care 'LLC.', 711 Berkshire Road, Daytona Beach, FL 32114, for as-needed Lot Clearance and Nuisance Abatement services, for a period of one year with two one-year options to renew (ITB No. 0115-2180).

SECTION 2. The City Commission finds that the bid submitted by Ultimate Kutz Service, Inc., is non-responsive.

SECTION 3. The bid of Veteran 1 Lawn Care 'LLC.', is hereby accepted subject to the terms and conditions of the bid documents. The total expenditure for FY 2015-2016 shall not exceed \$100,000.

SECTION 4. The Mayor and City Clerk are hereby authorized to execute an appropriate contract or such documents as may be required.

SECTION 5. The City Manager is authorized to exercise the City's options to renew the contract with Veteran 1 Lawn Care 'LLC.', and to expend such sums during renewal periods as are budgeted and appropriated.

SECTION 6. This Resolution shall take effect immediately upon its adoption.
