SECTION 1: OVERVIEW

SCOPE OF SERVICE: The City is requesting quotes to perform the following services. Quotes may be e-mailed to <u>PURCHASING@CODB.US</u>, faxed by 386-671-3964 or delivered to the Purchasing Department, 301 South Ridgewood, Room 146, Daytona Beach, FL 32114.

The City of Daytona Beach is seeking quotes for the Daytona Beach Police Department, but can be utilized by any department within the City of Daytona Beach. The vendor shall complete service on all vehicles and have ready for use no later than 45 minutes after arrival.

TERM: The Effective Date of this Agreement is the date in which the last party signs the Memorandum of Agreement. The Term of this Agreement is 1 year, commencing on the Effective Date. Any purchase order entered into prior to the expiration of the Term will remain valid. The City will have the option to renew this Agreement for up to 2 additional terms of one (1) year each, by providing Contractor written notice at least 60 days before the end of the current Term.

SECTION 2: GENERAL CONDITIONS:

ORAL STATEMENTS: No oral statement of any person shall modify or otherwise affect the terms, conditions or specifications stated in this agreement. All modifications to the agreement must be made in writing by the City of Daytona Beach.

AWARD: If awarded, the award will be made by The City to the lowest responsive and responsible vendor, which shall be determined in accordance with applicable rules and regulations governing purchases or agreements adopted and established by The City.

DOCUMENT DEEMED AS AN AGREEMENT: In the event that the City of Daytona Beach awards the project described herein to a Contractor and a purchase order is processed then this document shall become a legally binding agreement.

ERRORS: When an error is made in extending total prices the unit price will govern. Carelessness in quoting prices or otherwise will not relieve the vendor of its responsibility.

FEDERAL TAXES: All offers shall be exclusive of federal taxes. If the vendor believes that certain other taxes are properly payable by The City, he may list such taxes separately in each case directly below the respective item offer price. Tax exemption certificates will be furnished upon request.

FISCAL NON-FUNDING CLAUSE: In the event sufficient funds are not budgeted for a new fiscal period, the City shall notify the Contractor of such occurrence and the agreement shall terminate on the last day of the current fiscal year without penalty or expense to the City.

PERFORMANCE: During the performance of the agreement, the awarded vendor agrees as follows:

a. The awarded vendor will not discriminate against any employee or applicant for employment because of race, religion, color, sex or national origin.

b. Notices, advertisements and solicitations placed in accordance with federal law, rule or regulation shall be deemed sufficient for the purpose of meeting the requirements of this section.

PERMITS, ETC: All offers submitted shall exclude in the price the cost of any business or professional license, permits or fees required by The City or other agency having jurisdiction. Vendors are responsible for acquiring any permits but shall be reimbursed at the actual cost of such unless otherwise specified in the solicitation documents. Business or professional licenses costs are not reimbursable.

REJECTION OF OFFERS: The City reserves the right to accept or reject any or all quotations in whole or in part and to award by items, parts of items, or by any aggregate group of items specified. The City reserves also the right to waive technical defects when in its judgment the best interest of The City thereby will be served.

RULES AND REGULATIONS: All work performed shall be in strict compliance with Local, State and Federal laws, rules and regulations. Awarded vendor shall assume all liability for fines and penalties assessed by the authorities for any infractions.

UNIT PRICING AND QUANTITIES. If this solicitation requests submission of unit prices: (i) the successful Vendor will hold all unit prices bid firm for the duration of the Agreement, including any extension thereof, unless specifically authorized by the Agreement Documents; and (ii) quantities stated are an estimate only and no guarantee is given or implied as to quantities that will actually be required during the Agreement period. (iii) The City makes no guarantee of weekly volume.

RESTRICTIONS: Time, dollar, or quantity restrictions are not permissible. Quotes offered which include such restrictions will be rejected. Any variations from this specification shall be indicated on the quote sheet and shall be explained in detail on a separate attachment.

PRICE INCLUSIVE OF ALL COSTS: Quoted Price is inclusive of all of the Vendor's direct and indirect costs of performing the Work, including any surcharges, fuel charges, delivery charges, disposal charges, or other unspecified additional fees. The City will not pay for any fee not specified on the quote schedule.

NON-LIABILITY: The awarded vendor shall not be liable in damages for delay in shipment or failure to deliver services when such delay or failure is the result of fire, flood, strike, the transporting carrier, act of God, act of Government, act of an alien enemy or by any other circumstance which, in the Purchasing Agent's opinion, is beyond the control of the awarded vendor. Under such circumstances, however, the Purchasing Agent may, at her discretion, cancel the agreement.

OTHER CONSIDERATIONS: Quantities involved, time of delivery, purpose for which required, competency of vendor, his ability to render satisfactory service and past performance will be considered in determining responsibility.

CANCELLATION: The City may by written notice to Contractor terminate this Agreement, in whole or in part, at any time, either for the City's convenience or because of the failure of the Contractor to fulfill its contractual obligations. 1) Before terminating for convenience, City must provide Contractor at least 30 day's advance notice of termination. This Agreement will terminate automatically and without need for further notice upon the expiration of the notice period. 2) Before terminating due to Contractor's material breach of its contractor remedy the breach within 10 days of the notice, or within such longer period as may be reasonably required if the nature of the breach is that it cannot be remedied within 10 days of notice. This Agreement will terminate automatically and without need for further notice if Contractor fails to remedy the material breach within the period described in the City's notice of breach.

SPECIFICATIONS/DESCRIPTION OF EQUIPMENT: If any proprietary, trade, brand or manufacturers' name or part number is used herein in describing the required equipment, it shall be understood to indicate the minimum standard of composition and quality desired, and shall not be construed to exclude equipment that equals or exceeds the functional capability and quality of the named equipment. If offers are based on such equivalent equipment, indicate the manufacturers name, model, and number for the equipment and include any literature or other explanation of the equipment's quality or performance. In cases where it becomes necessary to determine whether or not a product offered is equal or equivalent to the product specified, the City of Daytona Beach, at its sole discretion, will make such determination.

NON-EXCLUSIVE CONTRACT. Award of this Contract will impose no obligation on the part of the City to use the successful bidder for all work of this type that may be required during the Contract period. This is not an exclusive contract. The City specifically reserves the right to concurrently contract with other companies for similar work if the City deems such action to be in the City's best interests. In the case of multiple term contracts, this provision will apply separately to each item.

If this solicitation is service related:

SERVICE FAILURES: Failure of an awarded vendor to provide services within the time specified, or within a reasonable time as interpreted by the Purchasing Agent or failure to make replacements of rejected articles as directed by the Purchasing Agent shall permit the Purchasing Agent to purchase in the open market articles of comparable grade to take the place of those rejected or not delivered. On all such purchases the awarded vendor shall reimburse The City within a reasonable time specified by the Purchasing Agent, for any expenses incurred in excess of the defaulted prices.

SERVICE WARRANTY: The following service warranty shall be included as a part of the service agreement. "In the event that it is determined that repairs/replacements are required as a result of negligence in performance of the maintenance service inspections, it will be the responsibility of the awarded vendor to make necessary repairs with no obligation to the City of Daytona Beach."

SECTION 3: INSURANCE:

Contractor will provide and maintain at Contractor's sole expense, insurance of the kinds of coverage and in the amounts set forth in this Article, primary and non-contributory with the City's own insurance, in form and from companies satisfactory to the City.

(a) Coverage and Amounts. Subject to paragraph (b), below, required coverages and amounts are as follows:

1. <u>Workers Compensation Insurance</u> – As required by Florida Statutes, Chapter 440, Workers' Compensation Insurance, for all employees of the Vendor, employed at the site of the work or in any way connected with the work, which is the subject of this service

The insurance required by this provision shall comply fully with the Florida Workers' Compensation Law and include Employers' Liability Insurance with limits of not less than \$500,000 per occurrence. Any associated or subsidiary company involved in the service must be named in the Workers' Compensation coverage.

- <u>Commercial General Liability Insurance</u>, including coverage for garage keepers liability for damage to vehicles in the care, custody and control of the Vendor, operations, independent Contractors, products-completed operations, broad form property damage, and personal injury on an "occurrence" basis insuring the Contractor and any other interests, including but not limited to any associated or subsidiary companies involved in the services being provided under this Agreement.
- 3. <u>Automobile liability Insurance</u> which shall insure claims for damages because of bodily injury or death of any person or property damage arising out of the ownership, maintenance or use of any motor vehicle used by the CONTRACTOR at the site of the project or in any way connected with the services being provided under this Agreement.

The limit of liability under the Commercial general liability and automobile liability policies will be a combined single limit for bodily injury and property damage of no less than \$1,000,000 per occurrence, project specific. If insurance is provided with a general aggregate, then the aggregate shall be in an amount of no less than \$2,000,000, project specific. The Risk Manager for the City may authorize lower liability limits for the automobile policy only, at the Risk Manager's sole discretion.

THE COMMERCIAL GENERAL LIABILITY INSURANCE POLICY SHALL NAME THE CITY AS AN ADDITIONAL INSURED.

Unless specifically waived hereafter in writing by the Risk Manager, Contractor agrees that the insurer shall waive its rights of subrogation, if any, against the City on each of the foregoing types of required insurance coverage.

Loss Deductible Clause: The City shall be exempt from, and in no way liable for, any sums of money that may represent a deductible in any insurance policy. The payment of such deductible shall be the sole responsibility of the Contractor or sub-Contractor providing such insurance.

(b) Required Changes in Coverage and Amounts of Coverage. The City may at any time require Contractor to increase the amount of coverage, change the terms of coverage, and provide additional or

different types of coverage, as the City may deem necessary; provided that the changes or increase in coverage are consistent with such requirements for similar operations and businesses then operating within the Central Florida area or are reasonable in light of prior claims made against Contractor's policies. Contractor must comply with such requirements within 30 days after the City's demand.

(c) Reasonable Deductible. Any insurance policy required by or pursuant to this Section may contain a reasonable deductible provision provided advance notice of said deductible provision is given by the Contractor to the City and approval from the Risk Manager for the City is given, which approval shall not be unreasonably withheld or delayed.

(d) Proof of Insurance. Contractor will furnish proof of the required forms and coverages referenced above to the Risk Manager for the City prior to or at the time of execution of this Agreement. Contractor will not commence work until all proof of such insurance has been filed with and approved by the Risk Manager. Contractor will furnish proof of any new or amended coverages to the Risk Manager promptly upon being directed to do so. The City may require Contractor to halt operations until Contractor has provided such insurance.

(e) Form of Evidence of Coverage. Contractor will furnish evidence of all required insurance in the form of certificate of insurance which will clearly outline all hazards covered as itemized above, the amounts of insurance applicable to each hazard, the expiration dates.

If requested by Risk Manager, Contractor will furnish copies of the insurance agreements to support the certificates of insurance and the copies of said insurance must be acceptable to the Risk Manager.

Anything to the contrary notwithstanding, the liabilities of the Contractor under this Agreement shall survive and not be terminated, reduced or otherwise limited by any expiration or termination of insurance coverage. Neither approval nor failure to disapprove insurance furnished by the Contractor shall relieve the Contractor or its sub-Contractors from responsibility to provide insurance as required by the agreement.

(f) Replacement Required. Contractor will file replacement certificates 30 days prior to expiration or termination of the required insurance occurring prior to the acceptance of the work by the City. If such insurance will lapse, the City expressly reserves the right to renew the insurance at Contractor's expense.

(g) Termination of Insurance. Contractor may not cancel the insurance required by this Agreement until all services are completed, accepted by the City, and Contractor has received written notification from the Risk Management Division of the City that Contractor may cancel the insurance required by this Agreement and the date upon which the insurance may be cancelled.

SECTION 4: SPECIFICATIONS:

QUOTE PRICE INCLUSIVE OF ALL COSTS: Quote Price is inclusive of all of the Vendor's direct and indirect costs of performing the Work, including any surcharges, fuel charges, delivery charges, disposal charges, or other unspecified additional fees.

AVAILABILITY AND COMPLETION TIMES: The vendor shall provide service a minimum of five (5) days per week, Monday thru Friday excluding nationally recognized holidays. Vendor shall be available to perform service between the hours of 8:00 A.M and 5:00 P.M. on weekdays.

The vendor shall complete service on all vehicles and have ready for use no later than 45 minutes after arrival.

INVOICES: All invoices shall be itemized using the line items contained on the quote form. Invoices must clearly identify the specific vehicle number, department, VIN number, license plate number, make, model, year of the vehicle, and <u>number of quarts of oil disposed</u>. All invoices must have a City representative signature and name printed on the invoice verifying the work has been performed, in order to get paid. Vendor shall submit invoices on a monthly basis. Monthly invoices shall include the amount of oil recycled (in quarts) and the number of oil filters recycled. An individual invoice shall be created for each participating department i.e., Police Department, Fire Department, Leisure Services, etc. All invoices shall be sent to City of Daytona Beach, Fleet Operations, PO Box 2451, Daytona Beach, FL 32115-2451.

LOCATION: The vendor shall have at least one established service facility within the City of Daytona Beach city limits or within 5 miles of the City of Daytona Beach city limits. Vendors shall indicate if any alternate locations may be used in conjunction with the primary location.

DAMAGE: Vendor shall be responsible for ensuring the vehicle leaves the facility in the same condition as when it arrives. The vendor shall be responsible for repairing damages to any vehicle if the damage was caused while in the care of the vendor.

PHYSICAL INSPECTION: The City reserves the rights to make unscheduled physical inspections of the vendor's facility for the purpose verify type of fluids and filters being used along with credentials of technician doing inspections.

VEHICLE SPREADSHEET: A spreadsheet listing department vehicles is attached to allow the vendor an approximate estimate of how many different makes, models and engine type of vehicles will be utilizing their service. The City in no way guarantees the makes, models or engine types and any listing received of City vehicles is subject to change without notice. (pages 12-28)

TAXES: All offers shall be exclusive of federal taxes. If the vendor believes that certain other taxes are properly payable by The City, he may list such taxes separately in each case directly below the respective item offer price. Tax exemption certificates will be furnished upon request.

REFERENCES: Vendor shall provide three (3) references. Please complete references only on the sheet provided.

UNABLE TO PERFORM SERVICES: In the event the vendor cannot perform these services within the timeframe stated herein, the City has the right to seek services from the next lowest vendor. Written documentation must be provided showing awarded vendor is unable to perform services.

ADDITIONAL DEPARTMENTS / VEHICLES: (i) Any department in the City of Daytona Beach may utilize this quote for the unit prices stated. (ii) The list supplied in this quote is for Police Department fleet only, but any other City vehicle is eligible to use this agreement. (iii) Any additional passenger cars purchased during the term of this quote shall be serviced at the unit prices stated herein.

MINIMUM TECHNICAL REQUIREMENTS

- Synthetic blend oil must meet or exceed vehicle manufacturers (OEM) classification for the type vehicle being serviced. Oil viscosity must meet all OEM vehicle requirements. All motor oil shall have a minimum of API starburst service minimum CI-4 Plus for diesel and SM for gasoline. Vendor shall list oil manufacturer and API service rating on the Bid Form for a reference.
- Oil Filters must meet or exceed vehicle manufacturers (OEM) specifications for filtration requirements. Vendor shall list manufacturer and micron filtration rating on the bid form for reference.
- All fluid levels (list attached) must be topped off with fluids of equal or which exceeds original product quality delivered by vehicle manufacturer (OEM).
- A minimum safety check must be completed during each service. Checklist attached. Safety inspection must be completed by ASE Certified Mechanic in Brakes and Front Suspensions and their signature must be on each completed safety inspection form. If any safety issue is discovered vehicle must be sent immediately to City Fleet Facility for repair.
- At no time shall the vendor repair, replace, modify or adjust any vehicle component not listed specifically within this Request for Quotes.
- The Preventive Maintenance Checklist must be completed for each vehicle immediately upon completion of a service the following must be faxed/e-mailed to City of Daytona Fleet Management. Vehicle Number (4 digit City ID), Mileage and hours, Invoice, Preventative Maintenance Checklist w/appropriate signature(s).
- The Contractor shall comply with all local, state and federal environmental laws.
- Contractor shall be able to demonstrate used oil and used fuel filters have been properly disposed of upon request of the city. Receipts from a used oil filter transporter would be sufficient.

Vendor shall identify an employee who will have the authority to resolve any disputed issues with the City.
