**AGREEMENT NO. 21-POL-ITB-399
AMENDMENT NUMBER 2**

This Amendment Number 2 is made on the date of execution by the County and amends Agreement Number 21-POL-ITB-399 (“Main Agreement”) dated 2/18/2021 between Redman Fleet Services, Inc. (“Contractor”) and the County Board of Arlington County, Virginia (“County”).

The County and the Contractor agree to amend the main contract called for under the Main Agreement as follows:

1. Provision #4, **RATES**, Paragraph VIII in Exhibit A – Scope of Work is hereby deleted and replaced with the following:
 - viii) Administrative Fee: The Contractor may charge the owner a one-time administrative fee applicable after the first seventy-two (72) hours of tow and/or impoundment.
FEE MAXIMUM OF \$150.00 WHEN PAID BY THE VEHICLE OWNER & MAXIMUM OF \$75.00 WHEN PAID BY THE COUNTY. THIS AMOUNT WILL BE APPLIED TOWARD THE COST OF A MANDATORY DEPARTMENT OF MOTOR VEHICLES MECHANICS LIEN REQUEST WHICH MAY BE FILED ON THE THIRD (3RD) DAY AFTER THE TOW. THE FEE COVERS THE INITIAL OWNER TRANSCRIPT REQUEST, THE RECORD REQUEST, THE INDEPENDENT APPRAISAL & ADMINISTRATIVE CLERICAL WORK REQUIRED BY VIRGINIA LAW CODE 46.2-644.01-46.2-644.03
2. Provision #18, **CHARGES TO OWNER OR OPERATOR**, Paragraph XIV in Exhibit A – Scope of Work is hereby deleted in its entirety.
3. **EXHIBIT B – PRICING** is hereby deleted and replaced with the attached document “Exhibit B – Pricing”

All other terms and conditions of the Main Agreement remain in effect.
