AGREEMENT NO. 22-DES-RFPLW-465
AMENDMENT NUMBER 4**

This Amendment No. 4 ("Amendment") is made on July 1, 2023, by the County and amends Agreement Number 22-DES-RFPLW-465 dated April 6, 2022 ("Main Agreement") between First Transit, Inc. ("Contractor") and the County Board of Arlington County, Virginia ("County").

The County and the Contractor agree to amend the main contract called for under the Main Agreement as follows:

1. **Contract Renewal:** Pursuant to Contract Clause 4. Contract Term, this contract is hereby renewed for one (1) additional 12-month period, from July 1, 2023, to June 30, 2024, with three (3) additional 12-month periods remaining.
2. **Price Adjustments:** Pursuant to Contract Clause 6. Contract Price Adjustments, the adjustments for services beginning July 1, 2023, to the hourly rate(s) will not exceed the 4.9% percentage of change in the U.S. Department of Labor Consumer Price Index, All Items, Unadjusted, Urban Areas ("CPI-U") for April 2023.
3. **Section 22. COVID-19 Vaccination Policy For Contractors** is hereby removed in its entirety.
