## **RESOLUTION NO. 17-352**

A RESOLUTION ACCEPTING BIDS AND APPROVING THE PURCHASE OF HIGH CALCIUM QUICKLIME AND SODIUM CHLORIDE FOR USE IN THE BRENNAN WATER TREATMENT FACILITY FOR A ONE-YEAR TERM WITH TWO ONE-YEAR RENEWAL OPTIONS: AUTHORIZING EXPENDITURE IN A TOTAL AMOUNT NOT TO EXCEED \$1,420,000 TO PURCHASE THE CHEMICALS AS NEEDED DURING FISCAL YEAR 2017-2018; AUTHORIZING THE CITY MANAGER TO EXERCISE RENEWAL OPTIONS AND AMEND AGREEMENTS TO IMPLEMENT RATE INCREASES. SUBJECT TO BUDGETING AND APPROPRIATION, AND TO EXPEND SUCH FUNDS AS ARE BUDGETED AND APPROPRIATED DURING THE RENEWAL PERIODS TO PURCHASE THE CHEMICALS; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, bids for chemicals needed for operation of the City's water treatment

facilities for fiscal year 2017-2018 were duly called for and advertised; and

WHEREAS, all bids received were opened on July 20, 2017, and are listed on the

schedule attached hereto and made a part hereof; and

WHEREAS, the Business Enterprise Management Director recommends the

acceptance of the lowest and best bids from responsible and responsive bidders; and

WHEREAS, the Chief Financial Officer has submitted a Sufficiency of Funds

Certificate.

## NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF

THE CITY OF DAYTONA BEACH, FLORIDA:

SECTION 1. The City Commission finds that the lowest and best bids submitted by responsible and responsive bidders are the following:

SECTION 5. The City Manager is hereby authorized to exercise the renewal options, amend agreements to implement any rate increases as provided for in the agreements, and expend such sums during renewal terms as are budgeted and appropriated.

SECTION 6. The City Manager is hereby authorized to expend such funds as are budgeted and appropriated during the renewal periods to purchase the chemicals. SECTION 7. This Resolution shall take effect immediately upon its adoption.
