

AGREEMENT NO. 430-10
AMENDMENT NUMBER 6

This Amendment Number 6 ("Amendment") is made on the date of execution of the Amendment by the County and amends Agreement Number 430-10 dated June 28, 2011 ("Main Agreement") and made between The Animal Welfare League of Arlington (AWLA) ("Contractor") and the County Board of Arlington County, Virginia ("County").

Whereas the County and the Contractor desire to amend the Contract Term under the Main Agreement, the Contractor and the County, in consideration of the promises and other good and valuable consideration specified in this Amendment, amend the Main Agreement as follows.

1. REVISE THE CONTRACT TERM PARAGRAPH TO READ AS FOLLOWS:

The Work shall continue from July 1, 2016, and be completed no later than June 30, 2017 ("Sixth Subsequent Contract Term"), subject to any modifications as provided for in the contract documents. Upon satisfactory performance by the Contractor and with the concurrence of the Contractor, the County may authorize continued operations of the Contractor for not more than ten (10) additional twelve (12) month periods from July 1, 2011 to June 30, 2021 (Each such period shall be referred to as a "Subsequent Contract Term"). The Contract Amount for each Subsequent Contract Term shall be in an amount mutually agreed upon but which will in no event exceed the Funds appropriated for the service by the County Board of Arlington. The total Contract Amount may be increased or decreased during the Initial and Subsequent Contract Terms if available funds exceed or, in the alternative, are not sufficient to maintain the current service levels.


2. CONTRACT AMOUNT AS FOLLOWS:

The total payment for all tasks under this Agreement shall not exceed \$1,419,517.00


All other terms and conditions of the Main Agreement, as amended shall remain in full force and effect.
