## **AGREEMENT NO. 20-741-EP** AMENDMENT NUMBER No. 2

This Amendment Number 2 is made on November 30, 2020, and amends Agreement Number 20-741-EP dated February 5, 2020, ("Main Agreement") between Grafton School, Incorporated ("Contractor") and the County Board of Arlington County, Virginia ("County").

The County and the Contractor agree to amend the Contract Term and Exhibit A, Pricing Schedule called for under the Main Agreement as follows:

#### 1. ITEM 1 is hereby deleted in its entirety and replaced as follows:

- 1. The Contractor agrees to provide the following services to the County:
  - Residential Room & Board dedicated space to reside, sanitary conditions, personal care items, meals, snacks, and shelter at a level of supervision necessary to comply with the Commonwealth's residential services licensing requirements.
  - Group Home Daily Supervision around the clock supervision by organizational staff.
  - Group Home Medical/Health Services access to medical care by a licensed physician, nurse, or medically trained professional.
  - Residential Supplemental Therapies goal-based interventions with clear documentation/notes regarding goal addressed, the intervention used, the resident's response/input, and plans for follow up activities.
  - Applied Behavior Analysis Services therapy that focuses on improving specific behaviors, such as social skills, communication, reading, and academics as well as adaptive learning skills, such as fine motor dexterity, hygiene, grooming, domestic capabilities, punctuality, and job competence. Upon prior approval from the Project Officer and the submission of an approved service plan, applied behavior analysis services may be utilized.

#### 2. Exhibit A is hereby replaced in its entirety with the attached Revised Exhibit A.

All other terms and conditions of the Main Agreement remain in effect.
