**AMENDMENT NO. 3 TO INTERLOCAL AGREEMENT FOR
LANDING PERFORMANCE STAGE**

CONTRACT # C19-2852-TDD

This Amendment No. 3 hereby amends the Interlocal Agreement effective October 1, 2019, by and between Okaloosa County, Florida ("County") and City of Fort Walton Beach ("City"), for Landing Performance Stage ("Agreement"), also known as County Contract No. C19-2852-TDD.

WITNESSETH:

WHEREAS, the cultural review required for the U.S. Army Corps of Engineers permit has resulted in delays; and

WHEREAS, both parties desire to extend the Agreement for one year due to permitting delays.

NOW THEREFORE, in consideration of the mutual covenants herein and other good and valuable consideration, the parties hereby agree to amend the Agreement as follows:

1. Section 3 shall be amended as follows: "...provide the requisite documentation for payment by September 29, 2020 ~~2021~~ 2022...2023"
2. This Amendment No. 3 shall be effective upon execution by the County.
3. All other provisions of Contract # C19-2852-TDD shall remain in full force.
