
FIRST AMENDMENT TO THE AGREEMENT BETWEEN OKALOOSA COUNTY, FLORIDA AND MOHAWK VALLEY MINING, LLC
CONTRACT NO. C22-3258-PW

This First Amendment to the Agreement between Okaloosa County, a political subdivision of the State of Florida (the "County"), and Mohawk Valley Mining, LLC (the "Contractor"), executed this 20th day of June, 2023, is made a part of the original Agreement dated October 4, 2022, Contract No. C22-3258-PW (the "original Agreement"), incorporated herein by reference. The County and Contractor hereby agree as follows:

1. **SCOPE OF SERVICES.** The County and Contractor wish to amend Section 2 and Attachment "A" of the original Agreement to add the following:
 - Rip Rap-pick up \$27.00 per ton
 - Rip Rap-delivered \$38.25 per ton
2. **OTHER PROVISIONS REMAIN IN EFFECT.** Except as specifically modified herein, all terms and conditions of the original Agreement between the parties, dated October 4, 2022 and any amendments thereto, shall remain in full force and effect.
3. **CONFLICTING PROVISIONS.** The terms, statements, requirements, or provisions contained in this Amendment shall prevail and be given superior effect and priority over any conflicting or inconsistent terms, statements, requirements or provisions contained in any other document or attachment.

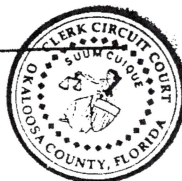
