**MEMORANDUM OF UNDERSTANDING  
BETWEEN  
CRESTVIEW FIRE DEPARTMENT AND OKALOOSA COUNTY  
DEPARTMENT OF PUBLIC SAFETY**

**THIS MEMORANDUM OF UNDERSTANDING, MADE AND ENTERED INTO THIS 12<sup>th</sup> day of MARCH, 2004 by and between the following: The City of Crestview for the Crestview Fire Department and Okaloosa County for the Department of Public Safety County Warning Point, herein referred to as parties.**

**WITNESSETH:**

**WHEREAS**, the parties hereto are geographically located in proximity to each other, and

**WHEREAS**, it is to the mutual advantage and benefit to the parties hereto that each of the parties effectively assist the other in the event of a communication failure or other occurrence causing the need to vacate or relocate from their respective communication center facilities.

1. That the parties will set forth the necessary policies and procedures to provide proper notification to the agencies they provide service for on how emergency dispatch operations will occur.
2. That the parties will provide, if possible, personnel to assist with the receipt and dispatch of emergency calls.
3. That the parties will facilitate the dispatch and receipt of jurisdictional emergency calls utilizing each other's primary fire frequency, telephone or fax systems.
4. That it is the responsibility of said parties for coordinating the run card assignments, responses of equipment and personnel in such a manner as to ensure that an adequate level of fire protection service remains available to each jurisdiction as prescribed by the parties' individuals polices, procedures or directives.
5. No party to this agreement shall be required to pay any compensation to any other party to this agreement for services rendered as the mutual advantages and protection afforded by this agreement being considered adequate compensation to all of the parties.
6. Any services performed or expenditures made in connection with furnishing mutual aid under this agreement by either party hereto shall be deemed conclusively to be for the direct protection of such party.
7. Any party to this agreement may withdraw at any time, upon thirty days written notice to each of the parties, and thereafter, such withdrawing party shall no longer be party to this agreement




