AMENDMENT NUMBER 1

This Amendment Number 1 ("Amendment") is made on the date of execution of the Amendment by the County and amends Agreement Number 656-13, also described historically as Contract 228-10, Contract No. 207-09 dated June 1, 2009, Invitation to Bid No. 88-03 and Contract No. 207-09LW dated on or around June 1, 2003 ("Main Agreement, as amended or "Contract") made between CSG Systems, Inc., 9555 Maroon Circle, Englewood, CO 80112 ("Contractor"), and the County Board of Arlington County, Virginia ("County").

WHEREAS, CSG Systems, Inc. and the County entered into the Main Agreement for CSG to provide Utility Billing Services; and

WHEREAS, CSG Systems, Inc. has transferred all the terms, conditions, and Scope of Work as contained in the Contract to DP2 Billing Solution, LLC, now known as DataProse, LLC pursuant to the General Assignment and Assumption Agreement ("Assignment Agreement") dated July 1, 2013, a portion of which is attached hereto; and

WHEREAS, under the Assignment Agreement DataProse, LLC has assumed all obligations and liabilities of CSG Systems, Inc. under this Contract by virtue of the above transfer; and

WHEREAS, the County consents to the assignment of this Contract to DataProse, LLC beginning upon July 1, 2013 ("Effective Date"); and

WHEREAS, in consideration of the promises and other good and valuable consideration specified in this Amendment, Main Agreement is amended as follows:

1. In place of CSG Systems, Inc. the County agrees that DataProse, LLC shall be the contracting party, and DataProse, LLC shall provide the services under the Agreement;
2. CSG Systems, Inc. confirms this transfer and waives any claims and rights against the County that it now has or may have in the future in connection with this Contract; and
3. DataProse, LLC agrees to be bound by and to perform this Contract in accordance with the conditions contained in the Contract Documents; and
4. The term "Contractor" in the Contract shall hereinafter mean DataProse, LLC.



NOW THEREFORE,

All other terms and conditions of the Main Agreement shall remain in full force and effect.
