#### AGREEMENT NO. 18-074-R AMENDMENT NUMBER 6

This Amendment Number 6 is made on  $\frac{3/9/2022}{2}$  by the County and amends Agreement Number 18-074-R ("Main Agreement") dated February 15, 2008 between Computing Systems Innovations (CSI) ("Contractor") and the County Board of Arlington County, Virginia ("County").

The County and the Contractor agree to amend the Main Agreement as follows:

# 1. Section 2: CONTRACT TERM.

Contract renewal from June 1, 2022 to May 31, 2023. Upon satisfactory performance by the Contractor, and with the concurrence of the Contractor, if the Supreme Court of Virginia renews their agreement identified in Attachment A, the County may elect to renew this Agreement for an additional one-year period under the same contract unit prices for not more than (1) additional twelve (12) month period from June 1, 2023 to May 1, 2024 ("Subsequent Contract Term"). However, if he Supreme Court of Virginia does NOT renew their agreement identified in Attachment A, this Agreement shall automatically expire on the date of the Supreme Court of Virginia's contract expiration date.

2. Incorporation of COVID-19 Vaccination Policy For Contractors is hereby added to the Contract Terms and Conditions.

# 43. COVID-19 VACCINATION POLICY FOR CONTRACTORS

Due to the ongoing COVID-19 pandemic, the County has taken various steps to protect the welfare, health, safety, and comfort of the workforce and public at large. As part of these steps, the County has implemented various requirements with respect to health and safety including policies with respect to social distancing, the use of face-coverings and vaccine mandates. To protect the County's workforce and the public at large, all employees and subcontractors of the Contractor who are assigned to this Contract, must be fully vaccinated against COVID-19. Any contractor employee or subcontractor who is not fully vaccinated should be following a weekly testing protocol as established by the Contractor, unless exempt pursuant to a valid reasonable accommodation under state or federal law.

3. **Incorporation of Sexual Harassment Policy** is hereby added to the Contract Terms and Conditions.

### 44. SEXUAL HARRASSMENT POLICY

If the Contractor employs more than five employees, the Contractor shall (i) provide annual training on the Contractor's sexual harassment policy to all supervisors and employees providing services in the Commonwealth, except such supervisors or employees that are required to complete sexual harassment training provided by the Department of Human Resource Management, and (ii) post the Contractor's sexual harassment policy in (a) a conspicuous public place in each building located in the Commonwealth that the Contractor owns or leases for business purposes and (b) the Contractor's employee handbook.

All other terms and conditions of the Main Agreement remain in effect.
