AGREEMENT NO. 20-259-R-1**

**AMENDMENT NUMBER 2
ASSIGNMENT OF AGREEMENT**

This Amendment Number 2 (“Amendment”) is made 3/10/2023 and amends Agreement Number 20-259-R-1 (“Main Agreement”) between Shaw Contract Flooring Services, Inc. dba Shaw Sports Turf, 185 South Industrial Boulevard, Calhoun, GA 30701 (“Contractor”), and the County Board of Arlington County, Virginia (“County”).

Shaw Contract Flooring Services, Inc. dba Shaw Sports Turf and the County entered into the Main Agreement for Shaw Contract Flooring Services, Inc. dba Shaw Sports Turf to provide *Athletic Surfaces – Natural & Synthetic Surfaces for Sport Fields, Tracks, Courts, Playground & Landscaping Applications.*

On February 7, 2022, Shaw Industries Group, Inc. (“SIG”) sold Shaw Contract Flooring Services, Inc. (“SCFS”). Due to that, SIG created a new entity Shaw Integrated and Turf Solutions Inc (SITS) for Shaw Sports Turf and Shaw Integrated Solution brands. In keeping up with the announcement, the contract is amended to change the contract name to Shaw Integrated and Turf Solutions Inc.

Shaw Integrated and Turf Solutions Inc. has assumed all of Shaw Contract Flooring Services, Inc. dba Shaw Sports Turf rights and obligations in the Main Agreement. The work and payment called for under this amendment shall be subject to all terms and conditions of the Main Agreement unless specifically changed by the terms and conditions of an additional amendment.

The County consents to the assignment of the Main Agreement to Shaw Integrated and Turf Solutions Inc. beginning on 3/10/2023 (“Effective Date”).

The Main Agreement is therefore amended as follows:


1. Shaw Contract Flooring Services, Inc. dba Shaw Sports Turf is in all instances replaced with Shaw Integrated and Turf Solutions Inc.;
2. The term “Contractor” in the Main Agreement means Shaw Integrated and Turf Solutions Inc.;
3. Pursuant to 4. Contract Term, this contract is hereby renewed for an additional 12-month period from **March 1, 2023, through February 29, 2024,** with no additional 12-month renewal periods remaining.

All other terms and conditions of the Main Agreement remain in full force and effect.


