AGREEMENT NO. 22-DHS-EP-445 AMENDMENT NUMBER 1

This Amendment Number 1 is made on the date of execution by the County and amends Agreement Number 22-DHS-EP-445 ("Main Agreement") dated September 29, 2021 between Alternative Paths Training School Inc. ("Contractor") and the County Board of Arlington County, Virginia ("County").

The County and the Contractor agree to amend the Main Agreement as follows:

1. REPLACE PARAGRAPH 4; CONTRACT TERM, IN IT'S ENTIRITY TO READ AS FOLLOW: 4. CONTRACT TERM

Time is of the essence. The Work will commence on October 1, 2021 and must be completed no later than June 30, 2022 ("Initial Contract Term"), subject to any modifications provided in the Contract Documents. Upon satisfactory performance by the Contractor the County may, through issuance of a bilateral Notice of Renewal, authorize continuation of the Agreement under the same contract prices for not more than four (4) additional 12-month periods, from July 1, 2022 to June 30, 2026 (each a "Subsequent Contract Term"). The Initial Contract Term and any Subsequent Contract Term(s) are together the "Contract Term".

- 2. PURSUANT TO PROVISION 4: CONTRACT TERM, THIS AGREEMENT IS HEREBY RENEWED FROM JULY 1, 2022 TO JUNE 30, 2023.
- 3. REPLACE PARAGRAPH 5 FOR THE TERM JULY 1, 2022 TO JUNE 30, 2023; CONTRACT PRICING, WITH THE FOLLOWING:

5. CONTRACT PRICING

The County will pay the Contractor in accordance with the terms of the Payment section below and up to a maximum of \$100,000.00 annually, at the rates detailed in Exhibit B for the Contractor's completion of the Work as required by the Contract Documents. The Contractor will complete the Work for the total amount specified in this section ("Contract Amount").

The Contractor shall bill Medicaid through Department of Medical Assistance (DMAS) for services provided to clients with Medicaid. The County will not compensate the Contractor for any goods or services beyond those included in Exhibit A unless those additional goods or services are covered by a fully executed amendment to this Contract. Additional services will be billed at the rates set forth in Exhibit B unless otherwise agreed by the parties in writing.

4. REPLACE EXHIBIT B PRICING SHEET FOR THE TERM JULY 1, 2022 TO JUNE 30, 2023 (ATTACHED)

All other terms and conditions of the Main Agreement remain in effect.
